

ECHO SPRINGS BARN RULES

- ❖ ALWAYS TREAT EACH OTHER AND ALL ANIMALS WITH RESPECT!
- ❖ ALL RIDING AND HORSE HANDLING IS DONE AT YOUR OWN RISK!
- ❖ PLEASE RESPECT HOURS OF OPERATION. 7AM TO 9PM, 7 DAYS/WEEK. PLEASE PROVIDE THE MANAGEMENT WITH NOTICE IF YOU HAVE ANY REASON TO BE ON PROPERTY OUTSIDE OF THESE HOURS.
- ❖ PLEASE DO NOT BRING YOUR DOGS TO THE BARN, WE HAVE OUR OWN DOGS.
- ❖ PLEASE PARK ONLY ON GRAVEL AREAS. PLEASE DO NOT DRIVE ON THE GRASS.
- ❖ CLOSE ALL GATES AND STALL DOORS. PLEASE DO NOT CLIMB OVER GATES; GO THROUGH THEM.
- ❖ NO SMOKING IN BARN. PLEASE DISPOSE OF BUTTS IN BUTT CANS.
- ❖ DO NOT ATTEND THE PROPERTY OR USE THE HORSES UNDER THE INFLUENCE OF DRUGS OR ALCOHOL
- ❖ NO SPEEDING IN THE DRIVEWAY!
- ❖ TURN OFF LIGHTS IN THE TACK ROOM AND AISLES, WHEN YOU HAVE FINISHED USING THEM.
- ❖ ALL HANDLERS & RIDERS INVOLVED WITH EQUINE ACTIVITIES MOUNTED OR NOT, MUST SIGN A WAIVER FORM BEFORE ENGAGING IN SUCH ACTIVITIES. NO EXCEPTIONS.
- ❖ IT IS A BOARDER'S RESPONSIBILITY TO ENSURE THAT ALL HIS/HER GUESTS HAVE COMPLETELY FILLED OUT AND SIGNED A WAIVER.
- ❖ BEFORE ANY PERSON MAY RIDE OR HANDLE A HORSE WHICH HE OR SHE DOES NOT OWN, WRITTEN PERMISSION FROM THE HORSE'S OWNER MUST BE DELIVERED TO MANAGEMENT, AND THAT PERSON MUST HAVE A WAIVER SIGNED.
- ❖ ALL CHILDREN MUST BE SUPERVISED. MINORS UNDER THE AGE OF 14 MUST BE UNDER THE DIRECT SUPERVISION OF A RESPONSIBLE ADULT AT ALL TIMES!
- ❖ NO RUNNING, YELLING, SHOUTING, THROWING THINGS, OR ROWDY BOISTEROUS PLAY, BEHAVIORS LIKE THIS ARE NOT PERMITTED AT ANY TIME. NO CLIMBING ALLOWED ON THE FARM EQUIPMENT, FENCES OR GATES.
- ❖ ABSOLUTELY NO JUMPING WITHOUT A HELMET. IF UNDER 18, AN INSTRUCTOR OR ADULT MUST BE PRESENT.
- ❖ IF A HORSE GETS LOOSE, YELL "**HORSE LOOSE**" AND MOVE TO A SAFE POSITION.
- ❖ DO NOT FEED ANY HORSE BUT YOUR OWN WITHOUT OWNER'S PERMISSION.
- ❖ PLEASE DO NOT HELP YOURSELF TO HAY, FEED OR BEDDING WITHOUT ASKING MANAGEMENT FIRST.
- ❖ PLEASE NOTIFY MANAGEMENT OF ANY NECESSARY REPAIRS, MAINTENANCE, PROBLEMS, OR NEEDED SUPPLIES SO THAT REPAIRS MAY BE MADE OR PROBLEMS REMEDIED AS SOON AS POSSIBLE.
- ❖ IF YOU HAVE CONCERNS ABOUT A HORSE (HEALTH/SAFETY/ETC) PLEASE REPORT IT TO THE MANAGEMENT IMMEDIATELY. IF YOU NOTICE A HORSE INJURED, UNWELL, OR OTHERWISE ACTING DIFFERENTLY TO THEIR NORMAL BEHAVIOR; MINOR INJURIES AND MEDICAL CONDITIONS MAY BE TREATED MORE SUCCESSFULLY IF BROUGHT TO OUR ATTENTION EARLY.

ECHO SPRINGS BARN RULES

- ❖ IF SOMEONE DOES SOMETHING CLEARLY WRONG AND IT IS A SAFETY ISSUE/HAZARD LET THE MANAGEMENT KNOW. DON'T CONFRONT THE PERSON UNLESS A HORSE OR PERSON IS IN IMMEDIATE DANGER.
- ❖ ANY CONCERN, QUESTION, REQUEST OR COMPLAINT SHOULD BE DIRECTED TO THE MANAGEMENT
- ❖ KEEP YOUR HORSE HALTERED AND ON A LEAD AT ALL TIMES WHEN OUT OF THE STALL OR PASTURE. DO NOT LEAVE HORSES UNATTENDED IN ARENAS OR WHILE TIED.
- ❖ PICK UP YOUR HORSE'S MANURE FROM THE AISLES, ARENAS, AROUND THE TRACK, THE PARKING LOT, AND AROUND THE BARN. WHEELBARROW AT THE BACK OF THE BARN.
- ❖ CLEAN UP MANURE, TRASH AND DEBRIS OF ANY KIND IMMEDIATELY. **DO NOT WAIT UNTIL AFTER YOU RIDE.**
- ❖ ALL GARBAGE GOES IN THE RESPECTIVE GARBAGE BAGS LOCATED AT THE FRONT OF THE BARN.
- ❖ REMOVE YOUR HALTER FROM CROSS TIES, SHEETS OR BLANKETS ON THE AISLE FLOORS PRIOR TO LEAVING THE GROOMING STATION, THIS IS FOR THE SAFETY OF THE HORSE AND IT IS RESPECTFUL TO THE SHARED SPACE.
- ❖ KEEP THE AISLES CLEAN AND TIDY FOR YOUR SAFETY AND THE SAFETY OF OTHERS.
- ❖ PICK UP AFTER YOURSELF AND SWEEP AREA THAT YOU USED (LEAVE THE PLACE YOU USED AS CLEAN AS OR CLEANER THAN WHEN YOU CAME).
- ❖ PLEASE DO NOT WASTE WATER; TURN OFF WATER AFTER USE AND USE BUCKETS WHENEVER POSSIBLE. PLEASE COIL HOSES WHEN YOU ARE DONE USING THEM.
- ❖ ALL TACK NOT BEING USED MUST BE RETURNED TO THE LOCKERS OR TACK ROOM PRIOR TO BEGINNING OF LESSON. THIS MEANS ALL BRUSHES; SPRAYS AND PERSONAL ITEMS MUST BE STORED IN LOCKERS OR TACK ROOM FOR THE SAFETY OF OTHERS AND ESPECIALLY THE HORSES.
- ❖ PLEASE DO NOT BORROW SOMETHING THAT ISN'T YOURS. DO NOT USE ANYONE'S TACK, GROOMING SUPPLIES OR ANY EQUIPMENT THAT IS NOT YOUR OWN WITHOUT EXPLICIT PERMISSION TO DO SO.
- ❖ STORE PERSONAL TACK, FEED/WATER BUCKETS, ETC IN ASSIGNED LOCKERS; OR REMOVE FROM PROPERTY AFTER EACH VISIT.
- ❖ A LOCKER IS AVAILABLE TO RENT FOR TACK AND PERSONAL ITEMS. DO NOT STORE ANY FORM OF FOOD IN YOUR LOCKER THAT IS NOT IN A SEALED CONTAINER. THIS IS TO HELP PREVENT RODENTS.
- ❖ ALL HALTERS, LEADS, BOOTS, SHEETS AND BLANKETS ETC SHOULD BE CLEARLY IDENTIFIED AND IN THE OWNERS DESIGNATED LOCKER.
- ❖ PLEASE MAKE SURE ALL TACK, BRUSHES, SADDLES ETC ARE PICKED UP AND PLACED BACK IN THE RESPECTIVE AREA.
- ❖ DO NOT MOUNT OR RIDE A HORSE IN THE BARN. NO RIDING IN THE AREA IN FRONT OF THE BARN.
- ❖ ALL HORSES MUST BE SIGNED IN/OUT OF THE PROPERTY INDICATING DEPARTURE DATE/TIME, HORSE NAME, RIDER NAME, DESTINATION AND EXPECTED DATE/TIME OF RETURN. IF YOU RIDE ON ROADS/TRAILS IN THE AREA PLEASE BE COURTEOUS TO OUR NEIGHBORS.
